 Transit Investment During the fiscal year ended June 30, 2014, Tri-State Transportation Campaign was engaged in building public support for transit projects and/or more transit investments in the I-287/Tappan Zee Bridge Corridor (which resulted in recommendations for seven new bus routes between Rockland and Westchester counties) and New York City's Select Bus Service (SBS) resulting in NYC Department of Transportation studying a more robust configuration of SBS on Woodhaven Boulevard in Queens, highlighted the impact of budget proposals on the MTA's budget (helped spare \$10M in state diversions from the transit agency), and helped ensure additional funds were used to expand Sunday service for Suffolk County Transit

 Pedestrian Safety During the fiscal year ended June 30, 2014, Tri-State Transportation Campaign advocated for an increase in pedestrian safety This resulted in the annual release of our Most Dangerous Roads analysis in the 3 states, the passage of speed cameras in NYC, Long Island, Albany, and New Rochelle to reduce speeding, and a focus on pedestrian safety in Connecticut around transit hubs and dangerous roadways

 Sustainable Transportation During the fiscal year ended June 30, 2014, Tri-State Transportation Campaign advocated for projects and initiatives that support multi-modal transportation options such as walking and biking throughout New York, New Jersey, and Connecticut This led to the adoption of Vision Zero by NYC Mayor de Blasio and the New York City Council, increased agency and public support for the redesign of the Sheridan Expressway in the South Bronx, and approval for bike lanes in Ocean County, New Jersey
