Sustainable Transportation: During the fiscal year ended June 30, 2015, Tri-State Transportation Campaign advocated for reform at the Port Authority, worked with legislators and partners to advance the redesign of the Sheridan Expressway in the South Bronx, worked to build support for the protection of dedicated transportation revenues in Connecticut and helped communities throughout Westchester County design Complete Streets initiatives.
