IN NEW JERSEY, WE SUCCESSFULLY ADVOCATED FOR AN INCREASE IN STATE FUNDING FOR NJ TRANSIT AND ARE WORKING WITH LEADERSHIP IN THE GOVERNOR'S OFFICE AND THE STATE SENATE TO PASS LEGISLATION TO REFORM NJ TRANSIT'S BOARD OF DIRECTORS. THAT LEGISLATION WAS SIGNED BY GOVERNOR MURPHY IN DECEMBER 2019.
